

DEWITT SCHOOL BOARD

July 13, 2017

The Board of Directors of the DeWitt School District met in its regular monthly meeting on Thursday July 13, 2017, at 7:00 p.m. in the Board Room of the Administration Offices.

The meeting was called to order by President Brad Koen. Others present were Vice-president Drew Whiting, Secretary Shawanna Wansley, and Board Members April Herring, and Johnny Lockley, along with Superintendent Dr. Lynne Dardenne. Kenneth Graves and Bruce Morgan were absent.

Consent Agenda

Minutes – A motion was made by Mr. Whiting to approve the June 13, 2017, meeting with change. Second by Mrs. Herring. Motion carried 5-0. (7:03 p.m.)

Financial – Mrs. Herring made a motion to approve the June financial report as presented. Second by Mrs. Wansley. Motion carried 5-0. (7:08 p.m.)

Electronic Transfer of Funds – A motion to approve the electronic transfer of funds, if needed, was made by Mrs. Herring. Second by Mr. Lockley. Motion carried 5-0. (7:10 p.m.)

Election Resolution - Due to there being no opposition and no proposed millage increase or other ballot issues, the law allows school boards, by Resolution, to request the County Board to open no polling places on election day so the election can be conducted by absentee and early voting only. Therefore, Mr. Whiting made a motion to adopt this resolution. Second by Mr. Lockley. Motion carried 5-0. (7:12 p.m.)

Handbook Approval – Mr. Whiting made a motion to approve the recommended changes to student handbooks for 2017-2018 and authorize the printing of these. Second by Mrs. Herring. Motion carried 5-0. (7:30 p.m.)

Chromebook Purchase Approval – A motion was made by Mrs. Herring to approve purchasing three Chromebook carts with management system and 90 chromebooks. One cart for grades three, four and five at a total cost of \$26,423.50 to be purchased with NSLA funding. Second by Mrs. Wansley. Motion carried 5-0. (7:38 p.m.)

Science Curriculum Approval – Mr. Lockley made a motion to approve Interactive Science as Science curriculum for grades 3-8 at a cost of approximately \$55,000.00. Second by Mr. Whiting. Motion carried 5-0. (7:43 p.m.)

Student Transfer Requests - A motion was made by Mrs. Herring to grant student transfer requests. Four students from Stuttgart to DeWitt and one student from DeWitt to Stuttgart. Second by Mr. Whiting. Motion carried 5-0. (7:46 p.m.)

Policy Changes – Mr. Whiting made a motion to accept the changes to meal charges, policies 4.51 and 7.17, as presented; alternate meal proposal was withdrawn. Second by Mrs. Herring. Motion carried 5-0. (8:00)
