There will be no cost to the district. Second by Mr. Whiting. Motion carried 6-0.

**FFA** National Conference – Mr. Graves made a motion to approve the request for six (6) students and two (2) chaperones to attend the National FFA Conference in Indianapolis, Indiana on October 24–27, 2017. Second by Mrs. Herring. Motion carried 6-0.
